- a)** APPLICATION NO: 21/01658/CLEUD, APPLICANT: Ian Mosey, DESCRIPTION: Certificate of Lawfulness in respect of the activity of vehicle movements in breach of condition 01 of approval 11/00498/73A dated 06.09.2011 for more than 10 years before the date of this application
LOCATION: Blackdale Farm Coulton Lane Coulton Helmsley YO62 4NQ

The Parish Council object to this application as the original reasons for the restriction on vehicle movements still exists. There are many objections to this already noted by the local community and there is a lot of local concern about the adverse impacts of the vehicle movements. Blackdale Mill is in an AONB and is in danger of being too large for an environmentally sensitive area. There appear to be legal anomalies that need reviewing by Ryedale District Council in this application.

- b)** APPLICATION NO: 22/00177/FUL APPLICANT: B M & I M Mosey DESCRIPTION: Erection of an agricultural livestock building for the housing of pigs LOCATION: Mill Wood Farm Coulton Lane Coulton Helmsley YO62 4NQ

The Parish Council expressed concern about pollution into water courses and ground water in the local SSSI and the growth of large agricultural complexes in the AONB. However, concerning this application, the Parish Council agreed 'no objection'.
